This Program Memo (PM) transmits your Fiscal Year 2007-08 Title V Senior Community Service Employment Program (SCSEP) Revised Allocation and Contract Amendment #1. This amendment reflects a \$0.70 per hour federal minimum wage increase effective July 24, 2007.

Included with this PM are four copies of the amendment and a cover letter specifying other documents that are needed for execution of the amendment. Instructions for mailing these documents are included as well.

State General Funds

State General Funds may only be spent on participant wages. Area Agencies on Aging (AAA) should request enough state funds each month to fund the difference between the state minimum wage of \$8.00 per hour and the federal minimum wage of \$5.85 per hour.



Participant Wages and Fringe Benefits Expenditures

A minimum of 79 percent of the federal contract must be spent on participant wages and fringe benefits (PWFB). If unspent funds are anticipated, based upon a monitoring analysis of the PWFB expenditures, projects can spend a higher percentage of state funds for wages and a higher percentage of federal funds for associated fringe benefits. Contact your SCSEP Specialists to discuss acceptable options for the use of PWFB.

Budget Due Date

A revised SCSEP Budget (CDA 35) that incorporates the attached Title V Budget Display, Amendment #1 is due to your assigned AAA-Based Team Fiscal Specialist **as soon as possible, but no later than 30 days from the date of this PM**. Revised Budgets must be submitted electronically to the Fiscal Team using the CBSP fiscal mailboxes.
